- Branch Delegates to National Council (9)

**Nominations**, which must be in writing and comply with the registered rules of the Association, may be made at any time from 23/11/2018.

Nomination forms are available on request from the Returning Officer, Catherine Bernoth, or the Association.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Association's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than 2:30pm Australian Eastern Daylight Time (AEDT) on 10/12/2018**. Nominations cannot be withdrawn after 2:30pm (AEDT) on 10/12/2018.
